August 6, 2013
7:00 pm

Call to Order

Mayor Reed called the meeting to order at 7:00 p.m. Councilmembers present were Don Hayes, Faye Godwin, Richard Schmidt, John Taylor and Claire Williams. Mayor Reed declared that a quorum was present. Also present was the City Attorney Mr. Lindsey. Mayor Reed led the assembly in the Pledge of Allegiance.

Approval of Agenda

A motion was made by Ms. Godwin, seconded by Mr. Hayes, and unanimously adopted to approve the agenda for the meeting.

Approval of Minutes

2. Minutes of the Special Called Meeting of July 16, 2013

A motion was made by Mr. Schmidt to approve the minutes from the regular meeting of July 2, 2013 and the minutes of the two special called meetings of July 16, 2013 and July 23, 2013 and Ms. Williams seconded. The motion passed unanimously.

Public Hearing

1. Consideration of Millage Rate for Calendar Year 2013

Mayor Reed opened the Public Hearing. Kyle Jones reported a staff recommendation of 10.958 mills and explained that this is the same millage rate as last year. As there were no public comments either in favor or opposed, Mayor Reed closed the Public Hearing.

New Business

1. Item 13-640: Ordinance No 13-07-116 Adoption of Millage Rate for Calendar Year 2013

Mr. Taylor made a motion to approve Ordinance No. 13-07-116. Ms. Godwin seconded. The motion passed unanimously.

Public Comments

Resident Carlton J. Hattaway stated that although he had issue with the sound system in the past, tonight he can hear very well.

Chief Rook announced that he would be calling Town Hall meetings to inform the public of possible traffic issues during the Tomorrow World event planned for the end of September. He also reported an arrest of a suspected thief over the weekend.

Chief Lyle reported that Summer Day Camp is winding down. The Fire Department has been helping Public Works with cutting grass in the parks and on right of way. He has participated in two (2) meetings with local fire chiefs regarding Tomorrow World.

City Administrator Jim Williams stated that Public Works is doing an excellent job and deserves a pat on the back.

Ms. Williams made a motion to adjourn and Ms. Godwin seconded. The motion passed unanimously and the meeting adjourned at 7:16 p.m.
